**Notice is hereby given** that the Charleston County Board of Elections and Voter Registration will conduct the Special Election for the City of Folly Beach City Council on Tuesday, February 17, 2026. Any person wishing to vote in this election must register no later than Sunday, January 18, 2026. Voter registration by mail forms will be accepted if postmarked by Tuesday, January 20, 2026. If necessary, a runoff will occur on Tuesday, March 03, 2026.

This hearing will take place at the Charleston County Board of Voter Registration office at 4340 Corporate Rd., North Charleston, SC 29405. If necessary, the runoff hearing will be at 10:00 a.m. on Thursday, March 05, 2026.
