During the first three months of 2023, our team has been working to lay the foundation for a successful municipal election season. With elections in May, June, and November, we have a busy year ahead. Between election preparations, we have been revising our standard operating procedures, training our full-time staff, and conducting voter outreach.

Recently, we participated in the 2023 Black Expo in North Charleston, where we engaged with attendees about the importance of voting and voter education. You can view pictures of the event on **Page 8**. Going to the Black Expo has been an annual event for us for the past few years, and we look forward to next year's event!

In February, we held a special election for Charleston County School Board of Trustees District 6 and a Folly Beach Referendum. Sullivan's Island and Meggett are up next in May. Remember, there's no such thing as an off year. Make sure you know when your municipality's election is being held.

As election officials, we are continuously receiving training and education to give us the tools we need to best serve our voters. In February, our management team attended the 2023 South Carolina Association of Registration and Election Officials Legislative Conference to connect with other election officials in our state. We have been thrilled with the response from our community for the Adopt a Polling Location program, as many organizations and individuals have stepped up to volunteer their time and resources to support our efforts. By working together, we are building stronger relationships between the Board of Elections and our community partners, and we are fostering a culture of civic engagement and participation. # 2023 WINTER ELECTIONS

## Two Elections Kick Off 2023 Calendar

### City of Folly Beach Referendum

48 percent of eligible voters cast their ballots in the City of Folly Beach Referendum. Of these, more than 12 percent chose to vote early, while about four percent voted absentee. The vast majority decided to vote on Election Day, which was Feb. 7.

### School Board of Trustees District 6 Special Election


A special election was also held on Feb. 7 to fill a vacant seat on the School Board of Trustees for District 6. A little more than 9 percent of those who were eligible voted early. Full results for this election, and for the City of Folly Beach Referendum, can be found [on our website](#).



## Annual legislative conference held by the South Carolina Association of Registration and Election Officials

## Empowering and Educating Young Minds at Charleston Advancement Academy High School

In February, the Charleston County Board of Elections & Voter Registration served students from Charleston Advancement Academy High School's two campuses. Across two days, members of our outreach team spoke to dozens of students on both James Island and at Trident Technical College.



# COUNTYWIDE INITIATIVES HELP STAFF POLLS

## Two innovative programs see successful launches in 2022

The Charleston County Board of Elections and Voter Registration piloted two initiatives in 2022 that looked to give back to the community while providing qualified staff members to work at polling places.



As mentioned on **Page 9**, Adopt a Polling Location gives non-partisan groups the opportunity to "adopt" a polling location on Election Day. Staffers from each organization are trained to serve as poll managers.

Their pay for working the day is then donated directly to a local nonprofit of choice, reinvesting the funds into the community.

Six organizations participated in the program in 2022, including Charleston Parks Conservancy, Charleston Promise Neighborhood, The Exchange Club of Charleston, SC, the James Island Charter High School Wrestling Team, the Lowcountry Food Bank, and the South Carolina Stingrays. In 2022, APL participants raised more than \$10,000.

## DAY FOR DEMOCRACY

CHARLESTON COUNTY

Day for Democracy (DFD) provides Charleston County employees with training and additional pay for working at the polls on Election Day. Through this program, Charleston County workers are able to further serve their community without needing to take paid time off to perform this civic duty.

With DFD, voters are able to benefit by receiving reliable staffing and professional service, while trust is also built between Charleston County's employees and the citizens they serve.

128 Charleston County workers participated in the inaugural DFD initiative. An after-action survey found that nearly 95% of respondents said they would participate again.
